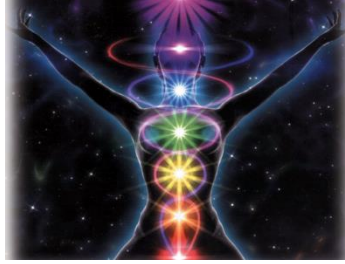

By signing this agreement, I agree to hold **Light News, Dr. Richard Jelusich and Lisa Steels** entirely free from any liability, regardless of whether injuries are caused by negligence.

Notice is hereby given that all arrangements made on behalf of participants are made by the organizers on the sole condition that the organizers shall not be held responsible for any injuries, death, accident, illness, delay, loss, damage, act of negligence, or irregularity. **Light News** acts only in the capacity as agents for the participants in all manners connected with the resort "Butterfly Garden Inn" - accommodations, sightseeing tours "Pink Jeep Tours", transportation whether by air, rail, bus, motorcar, boat or any other means. **Light News and its' Agents** relieves itself of all responsibility for any damage occasioned by any cause.

I also acknowledge there may be risks involved in **travel, yoga, and any and all other activities I choose to participate in**. These include but are **not limited to bodily injury including death, theft, or injury from outside activities I chose, and travel issues**. I agree to listen to my own body and work within my own limitations. If any movements hurt or are uncomfortable; **it is MY responsibility** to never take any exercise to a level of discomfort or pain.

I swear that I am participating voluntarily, and that all risks have been made clear to me. Additionally, I do not have any conditions that will increase my likelihood of experiencing injuries while engaging in this activity.

By signing below, I forfeit all right to bring a suit against **Light News, Dr. Richard Jelusich, Lisa Steels and their agents** for any reason. I will also make every effort to obey safety precautions as listed in writing and/or as explained to me verbally. I will ask for clarification and assistance when needed.

We **strongly** recommend purchasing Travel Insurance (Cancellation and Medical Insurance) to protect against cancellation fees and additional travel expenses that may incur before, after, or during your trip.

### **Required Documents**

A valid passport must be held by each passenger travelling internationally. Some countries require that your passport is valid for 6 months from your return date. Visas are required for entry into some countries. Please check with your local Embassy or Consulate of the country being visited, to learn about Visa requirements for your Nationality. Obtaining Visas is at the passenger's own expense.

## **Included in the Journey: What is Included or Not?**

### **Let us start with Registration Fees:**

- \$500 non-refundable registration fee
- Early Bird - \$1050 (less registration fee)
- After March 31<sup>st</sup> - \$1375 (less registration fee)

### **Included with Registration are:**

- 5 Nights' Accommodations
- 5 Breakfasts
- 4 Lunches
- Farewell dinner
- All site entrance fees
- Teachings with Dr. Jelusich and Lisa Steels
- Transportation to/from Flagstaff airport
- Arranged Transportation to sites – either with fellow journey participants or with Dr. Jelusich

### **Items not included in our costs:**

- Visa and passport charges
- Departure taxes
- Gratuities (some tours require gratuities be pre-paid)
- Extra meals not included in itinerary
- Items of a personal nature (i.e. laundry, drinks, telephone calls, personal clothing)
- Emergency evacuation
- Personal travel insurance
- Any item that is not specified as being included

## **Cancellation Policy**

To reserve your spot on the journey, please make a **\$500.00 U.S.** deposit by cheque/ PayPal/ Visa /MasterCard. Cheque / Check payable to: Light News 3639 Midway Dr. Ste B#297 San Diego CA, 92110-5254

**The Deposit is non-refundable** – however should you cancel your reservation 100 days or more before the start of the journey, you may apply your deposit toward another Light News event occurring within 12 months from the date of the initial journey that you registered for, if available. ### **Full Payment (Within 45 days of Journey):**

When you reserve, you may either pay in full or pay the deposit. Upon receipt of your payment, we will send you a receipt and invoice for the balance, if any. Full payment is due **August 1<sup>st</sup> 2016**; unless otherwise noted. You may pay with credit card, PayPal, cheque / check, bank draft / transfer.

# Journeys Within Light News

## Late Payment Fee (\$150.00 U.S.):

We must pay our tour operators in advance; therefore, we must collect your full payment no later than 45 days in advance of the start of the journey. If you do not pay in full in 45 days or more from the journey date, we will add a \$150 late payment fee to your invoice. If payment arrangements have been made with Light News those arrangements must be adhered to or the \$150 late fee will be applied.

## Cancellation Policy:

Please note that there will be **no refunds** or **discounts** in the event of late arrival, leaving early, flight cancellations, travel delays or illness. If you cancel your participation in a journey for any reason, the cancellation policy below will apply, with **no exceptions**. We wish we could compensate people for unforeseen circumstance (injury, family emergency, etc.), but we have costs already incurred when reserving the journey centers and hotels. We have designed our cancellation policy to be as compassionate as possible in the event that your plans change. But to protect yourself further, we strongly encourage you to purchase travel insurance.

## If YOU Cancel the Journey:

**100 days or more prior to the start of the journey, you receive:** 100% credit of the cost of the full journey, **less the \$500 Non-Refundable Deposit**. You can use this credit towards another Journey / Event with Light News within 12 months.

**0 - 100 days prior to the start of the journey: *NO* refunds or credits will be given.**

## If WE Cancel the Journey:

If we cancel a journey due to too few participants, we will refund to you all deposit and payments you have paid; less credit card / PayPal and or Bank processing fees. We cannot however compensate you for air or travel costs incurred. In the unlikely event that Light News must cancel a journey / event due to weather, natural disaster or political upheaval, we cannot guarantee a refund - it will be dependent on receiving a refund from the venue / tour operator we work with. To cover these risks, we highly recommend you purchase travel insurance.

The information contained in this document is correct to the best of the organizer's knowledge, but the organizer accepts no liability for any inaccuracies therein.

The organizers reserve the right to alter any itinerary or service at any time without penalty to the organizer. Any additional expense or cancellation costs shall be borne by the participant.
